EIL'S COMMITMENT TOWARD MICRO & SMALL ENTERPRISES

Ministry of Micro, Small and Medium Enterprises on 23rd March, 2012, had notified Public Procurement Policy, 2012 in respect of procurement of goods & services, produced & provided by Micro and Small Enterprises (MSEs).

EIL has been committed towards fulfilment of its obligations towards the development of Micro and Small Enterprises, including SC/ ST Enterprises. EIL has successfully implemented the provisions issued through Public Procurement Policy, 2012 for MSEs, in its procurement guidelines in the same year 2012. EIL is probably one of the few PSUs which implemented the said policy within few months of the notification of this policy.

From a Procurement of around 1.38% from MSEs in year 2011-12, EIL has achieved around 33% procurement of supplies & services from Micro and Small Enterprises during the year 2016-17.

This has involved concerted efforts in providing encouragement to such enterprises during enlistment as well bidding.

EIL has been organising / participating in various seminars and Vendor Development Programme organised by Ministry of Micro, Small & Medium Enterprises to encourage development of MSME sector including SC/ST Entrepreneurs.

EIL has been conducting vendor development programmes for MSME sector including SC/ST Entrepreneurs. As a part of Vigilance Awareness week, a meet titled as "Upliftment of SC/ ST Entrepreneurs through Public Procurement support and Vigilance Awareness" was conducted on 03.11.2016 exclusively for SC/ ST Entrepreneurs with an aim to create awareness about public procurement, its imperatives, precautions and opportunities for SC/ ST Entrepreneurs as well as benefits to them under various schemes.

PROCUREMENT PLAN OF EIL FROM MSES FOR FY 2017-18

EIL's Procurement Plan for Procurement from Micro & Small Enterprises is as follows:

- To sustain the procurement of materials / services in EIL from Micro & Small Enterprises in the year 2017-18 as compared to the year 2016-17.
- To encourage the SC/ ST Entrepreneurs to enlist as well as participate in EIL tenders/ enquiries through vendor developments programmes.
- To encourage SC/ ST Entrepreneurs to manufacture the products procured by EIL, by imparting training and visits to manufacturers of these products.
- Enlisting more & more MSEs capable of supplying the goods & services being procured in EIL.
- Procurement only from MSEs in respect of the 358 items reserved for procurement from MSEs.
- Organize/ associate with vendor development programmes for MSEs.
- Updating the EIL database for Micro or Small Enterprises and especially SC/ ST Entrepreneurs.
