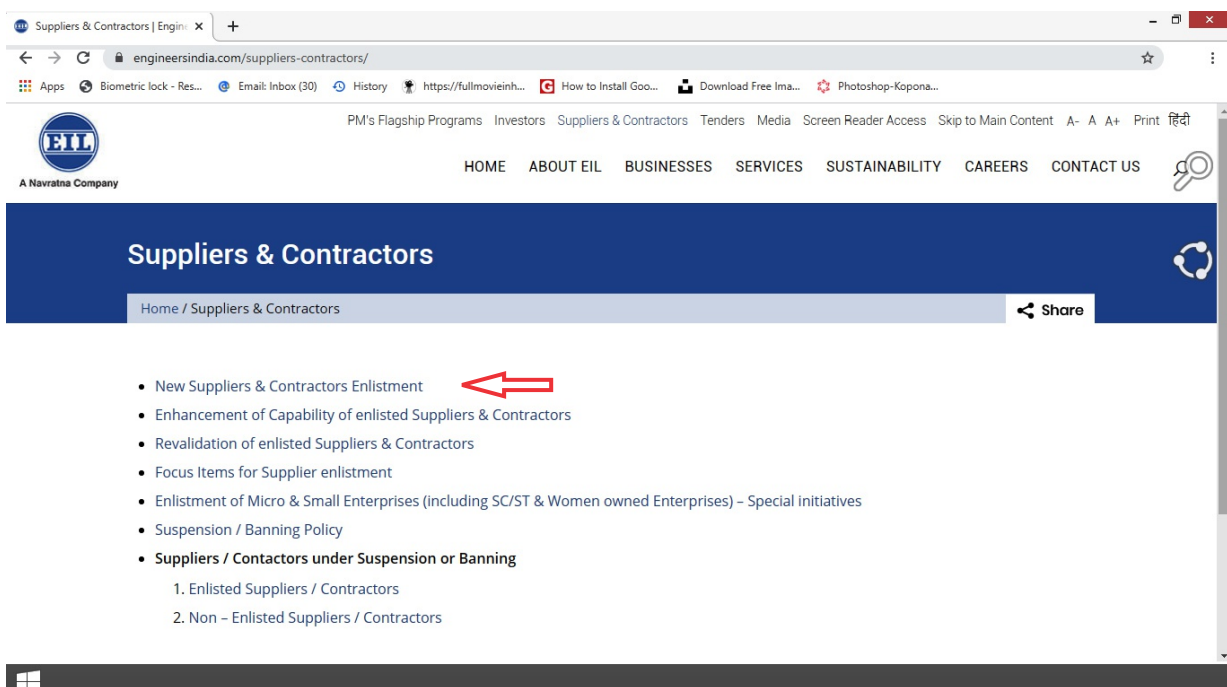

- EIL enlists suppliers and contractors for procurement of goods and services for various projects.

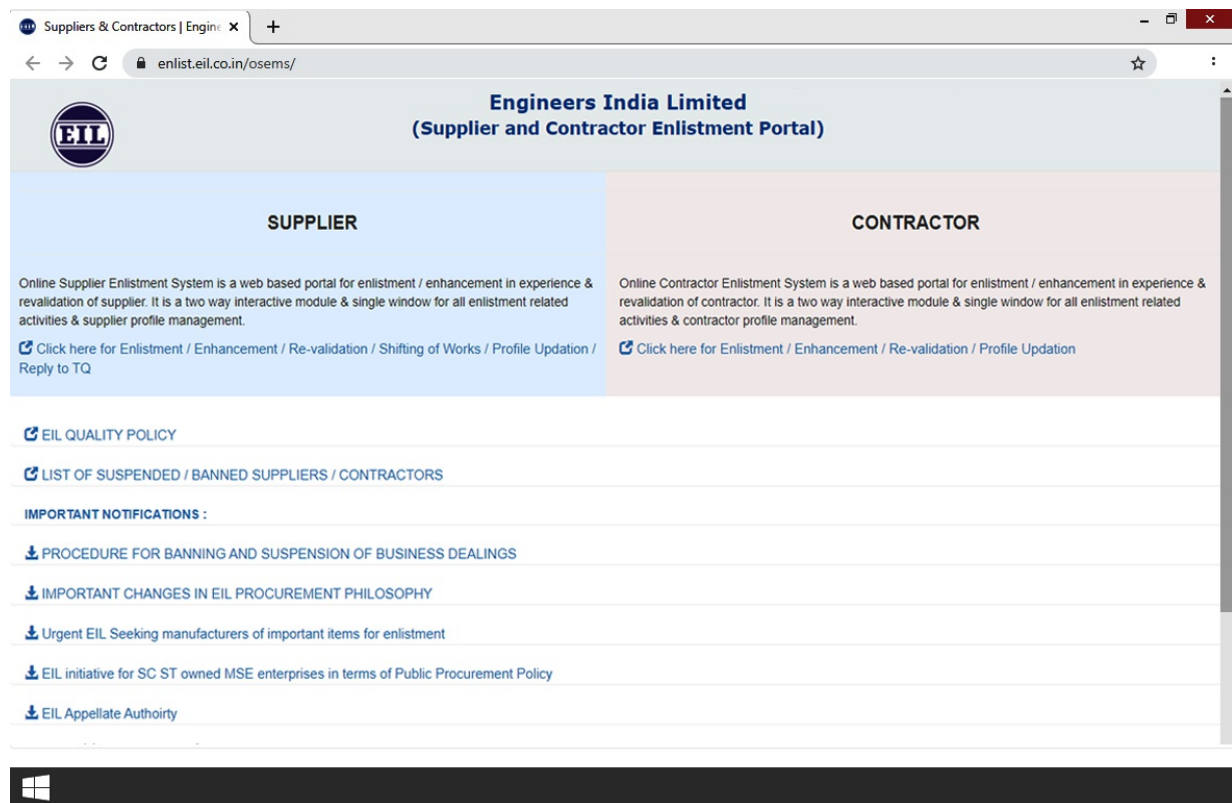

Stage-2: Shop Survey by EIL-Regional/ Foreign Procurement office (RPO/FPO)	Stage-3: Final approval

### Stage-2: Final Approval

Upon successful qualification in Stage-1, application shall be presented before EIL- Competent Authority/Committee for final approval.

Consequent upon approval of the Competent Authority/Committee, Enlistment letter shall be issued.
